City Administrator Scott Lambers confirmed for Councilmember Rezac that the funds for this upgrade are in the 2014 Budget under Capital Equipment.

A motion to approve Item No. 7K was made by Councilmember Rezac; seconded by Councilmember Azeltine. The motion carried following a unanimous vote of 8-0.

8. MAYOR'S REPORT

- A. Mayor Dunn recognized a very devoted individual to the City of Leawood, Jim Bays, who passed away this week. Jim was honored at the Annual Leawood Chamber of Commerce luncheon last December being brought into the "Hall of Fame." He was an Overland Park resident that had been with Ranchmart Ace Hardware Store for 30 years. He was the "Big Lion," head of the Leawood Lion's Club, on numerous occasions. He was involved with the Leawood Chamber of Commerce and numerous other causes. On behalf of the City of Leawood, Mayor Dunn wished his wife, Patty, and his entire family most sincere sympathies and requested a moment of silence to honor Jim.
- B. Attended a Leawood Chamber of Commerce ribbon cutting ceremony for Title Boxing Club, located at 123rd and State Line, now under new ownership. Mayor Dunn wished them much success with their beautiful revamped space.
- C. Congratulations to Leawood Foundation Chair Alice Hawk and her board members for hosting a terrific "Arti Gras" celebration for our community. They collaborated with the Arts Council on this fundraiser. Councilmembers Lou Rasmussen, Jim Rawlings and Julie Cain were also in attendance. Mayor Dunn thanked Cultural Arts Coordinator April Bishop and Parks and Recreation Director Chris Claxton and her team for working throughout the weekend to ensure its success. Participants included 55 adult artists and 42 junior artists who participated all over the metro-area. Four of the six adult artist winners were Leawood residents. There were nearly 700 visitors over the three-day show.

D. City Administrator Scott Lambers, Finance Director Dawn Long and Budget Manager Kathy Byard joined Mayor Dunn in meeting with Johnson County Appraiser Paul Welcome regarding updated information on properties throughout the County. The City of Leawood's appraised value increased to 4.86% from 2013-2014, compared to the increase of 1.3% in 2012-2013. The cycles of real estate include recession, recovery, expansion and contraction. currently in the recovery mode, which is bringing us back to the 2007 levels. The apartment market is currently realizing the largest growth. The residential market is approaching the expansion mode with 80% of our values seeing increases in the 2014 valuation year. 50% of all residential properties will see an increase of 5% or less. Positive sales price growth of existing homes includes North Leawood, which was up 28.62%; South Leawood was up 29.50%. The average appraised value for a home in Leawood is \$435,619 in 2014, as compared to \$423,417 in 2013, or 2.88% growth. The Appraiser's Office advised caution when calculating the tax revenue until the appeal process is complete.

City Administrator Lambers noted as a direct benefit of the increase in assessed valuations, the mill levy increase of one mill shown in the current Community Improvement Program [C.I.P.] and model forecasting for 2017, 2018 and 2019 has been pushed back to 2018, 2019 and 2020.

- E. Mayor Dunn expressed her appreciation to Sustainability Advisory Board Chair Debra Filla and Co-Chair Julie Cain and the Sustainability Advisory Board for hosting Leawood's 6th Annual Home Owners Association [HOA] meeting. There were approximately 130 people that attended, with over 40 Homes Associations representing 80% of homes in Leawood. There were excellent professional staff presentations provided by Public Works Director Joe Johnson, Parks and Recreation Director Chris Claxton, Parks Superintendent Brian Anderson and Community Development Director Richard Coleman. Information Services Director Mark Andrasik provided terrific IT support. Nearly all Councilmembers were in attendance. The meeting was very informative with many people expressing their appreciation for doing this on an annual basis.
- F. Mayor Dunn joined Kansas City, Missouri, Mayor Sly James and Johnson County Commission Chair Ed Eilert, along with other members of the Kansas City 2016 Host Committee, to present to the Republican National Committee Kansas City's bid to host the 2016 Republican National Convention. All went well, and we should learn if we make the site selection visit later this month. Due to weather issues, three other cities will present on March 21st.

G. Congratulations to Ironhorse Golf Course for being recognized for Environmental Excellence, achieving designation as a "Certified Audubon Cooperative Sanctuary" through the Audubon Cooperative Sanctuary Program for golf courses. Ironhorse is the 9th golf course in Kansas to receive this award, with only 884 in the world having been so designated. This recognition is for showing a strong commitment to its Environmental Program and providing sanctuary for wildlife on the golf course property. To reach certification, a course must demonstrate that they are maintaining a high degree of environmental quality in a number of areas, including Environmental Planning, Wildlife and Habitat Management, Outreach and Education, Chemical Use Reductions and Safety, Water Conservation, and Water Quality Management. Mayor Dunn expressed her appreciation to Ironhorse Advisory Board Chairman Dick Fuller and the entire Ironhorse Advisory Board, Parks and Recreation Director Chris Claxton and Troon Management for their commitment to this important mission.
